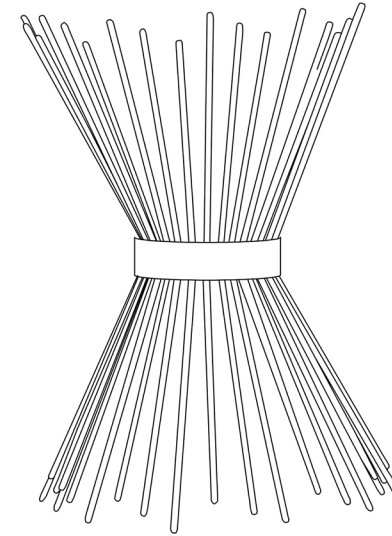

INSTALLATION INSTRUCTIONS
